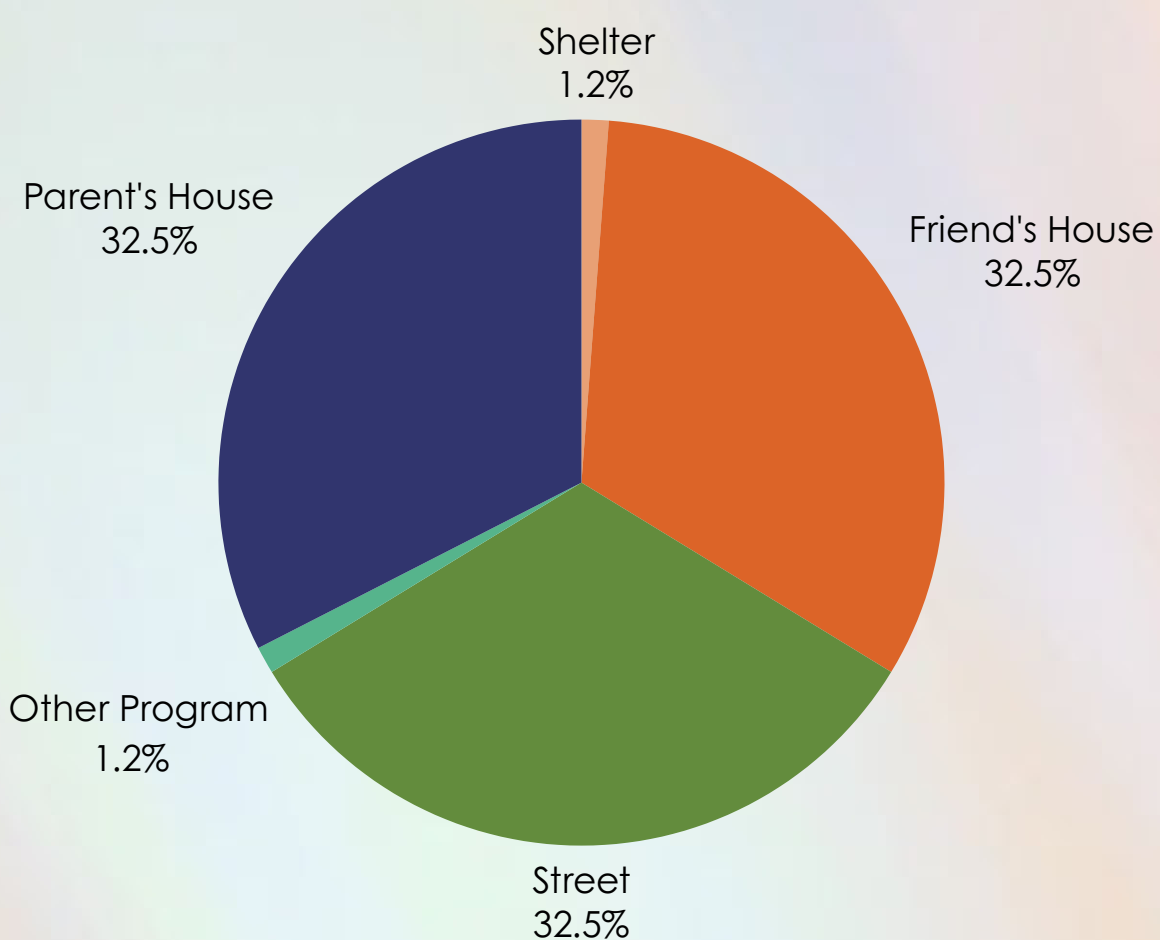

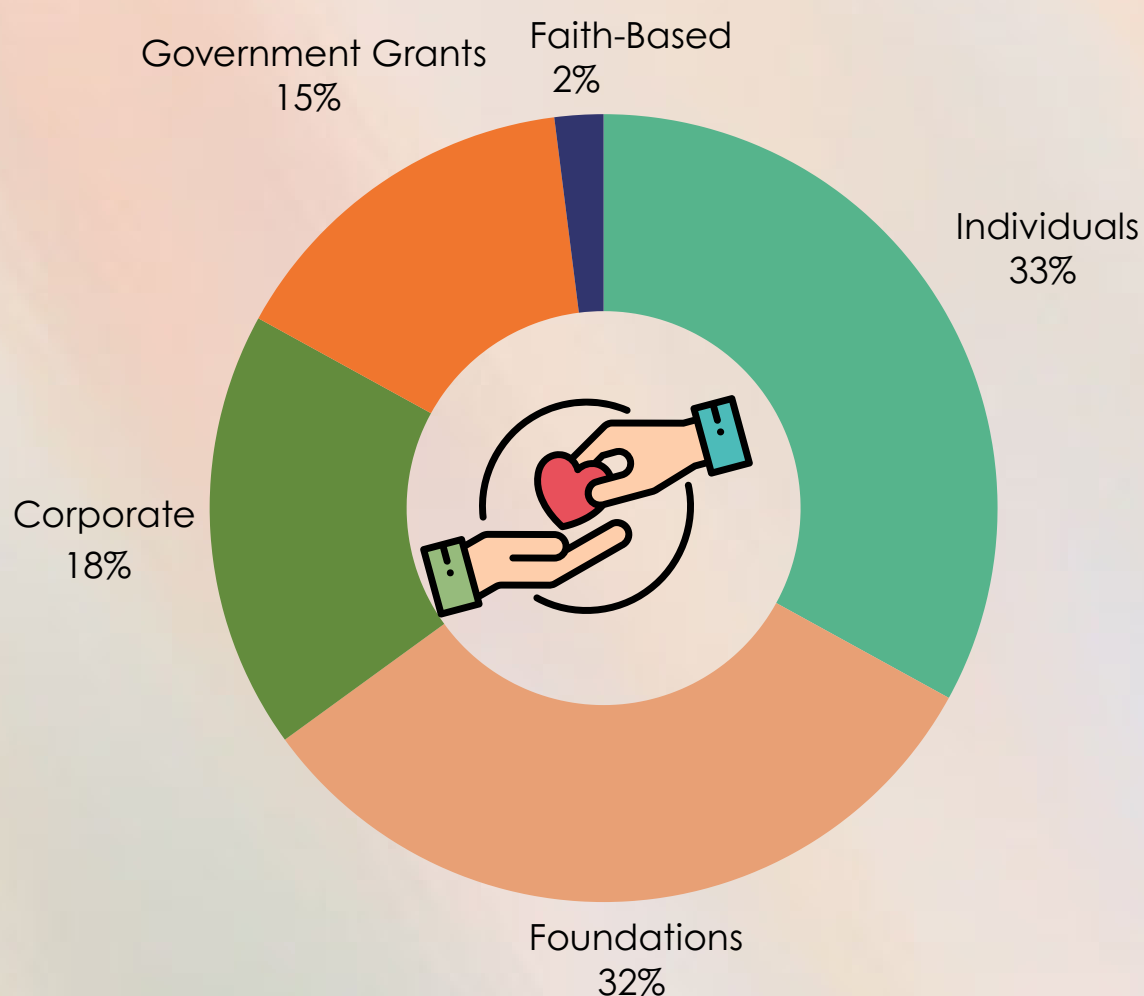

By the numbers!



In 2024, our direct service staff provided over 5,000 hours of 1:1 dedicated support, offering guidance, resources, and assistance to program participants.

We dedicated 1,000+ hours to employment-readiness services, helping participants with job coaching, resume building, skills training, and interview support.



We provided \$4,500 in flex funds to remove financial barriers to jobs, housing, and daily needs.



We served 16 LGBTQ+ young people in our Transitional Living Program and 15 in our Host Homes Program. 90% of the young people who exited our programs in 2024 went to housing of their choice.
